## The Benefits of Incident Reporting

As highlighted in the December 2019 FB-ISAO Newsletter, one of the earmarks of a successful information sharing organization is receiving confidential incident reports from members. Incident reports not only serve as notification an incident has occurred and used to request assistance (if needed), but incident reports provide a better situational awareness and understanding of the threat landscape through the submission of actual events. FB-ISAO released a beta version of our Incident Reporting (IR) capability in December 2019. With feedback from members, an updated version of our IR is now available on the #general channel of the FB-ISAO workspace.

**Why should members file an Incident Report?** In the context of information sharing organizations, such as FB-ISAO, incident reports help us provide awareness of threats to others, as appropriate. The more awareness we can share with others, the better prepared we will be individually and as a community. Being aware of actual incidents enhances FB-ISAO's analytical reports, and enables us to communicate relevant mitigation actions to help other members reduce the risk posed from similar activity, effectively respond to future events, or prevent similar incidents from occurring. ## Spotlight: Coronavirus

### Should my organization be concerned?

There is no cause for panic, but organizations do need to ensure they have an understanding of the situation within their business locations, as well as to be aware of any travelers who may have visited the area. Because of the recently completed holiday season, as well as Chinese New Year, it is possible there could have been travel in and around the area recently. If an organization has business interests in China and other parts of Asia that have been impacted, it would be important to follow the instructions of government and health officials. Any travelers to the affected region should notify the organization. Everywhere else, it is important that organizations review their health processes, as well as ensure they have visibility on any employees who may have traveled to the affected areas.

### What does it mean for Faith Based Organization?

As it pertains to Faith Based Organizations (FBO), this can have a tremendous impact due to the way the virus is spread. Regular attendees to worship services, or charitable events will largely adhere to government and health advisories and keep contact with others to a minimum in the affected areas, especially those that fall under [quarantine](#) conditions. This also means that outdoor events, or events that attract large gatherings, will be impacted. Because of the potential for lower turnout, and especially if the virus grows, it could have a financial impact on an organization's budget, especially one that may not have members using online tithing platforms and contribute with cash offerings.

On 11 February 2020, the virus was renamed from "ncov" to "covid\_19". The World Health Organization stated that "Having a name matters to prevent the use of other names that can be inaccurate or stigmatizing." Members of FB-ISAO can get topical updates via a Slack channel dedicated to this virus outbreak.
