# September is National Preparedness Month

<u>National Preparedness Month</u> (NPM) is an observance each September to raise awareness about the importance of preparing for disasters and emergencies that could happen at any time. The 2021 theme is "Prepare to Protect. Preparing for disasters is protecting everyone you love."

The goal of this month and the entire Ready campaign is to promote preparedness through public involvement. While many of the actions are directed toward individuals and their families, especially after the year that 2021 has been, it should be understood that businesses benefit in creating a culture of preparedness in all aspects of an individual's life. Additionally, organizations can take the same lessons, as well as other resources from Ready, gov to plan and prepare for the variety of all-hazards threats that they may be at risk from. ## See Something, Say Something

While there are no current known specific and credible threats to faith-based facilities, community members must stay vigilant and educate themselves on the indicators of terrorism-related suspicious activity. September 25 is National If You See Something, Say Something Awareness Day. The campaign is centered around the idea that as we go about our day, if we see something that doesn't seem quite right, we should say something. By being alert and reporting suspicious activity to local law enforcement, we can protect our family, neighbors, and our communities.

A great example of See Something, Say Something at work, occurred on March 14, 2021 when just before a service at the First Baptist Church in Brevard, North Carolina was set to begin, the security team noticed suspicious activity outside their facility through their security cameras. Upon further investigation, it was determined that there was an unknown type of device left outside. The church informed the Pastor, and then called the police. After the device was confirmed, the police cordoned off and evacuated the immediate area. Ultimately, the police confirmed that there were in fact several explosive devices, initially assessed at approximately 20, and the incident was called a "serious threat." Members should familiarize themselves with suspicious activity indicators because their awareness and vigilance may prevent an attack just like the one in this incident. Suspicious activity indicators for religious facilities may include damage to security devices like security lights or cameras, unattended packages and bags, or threatening emails. Individuals can play a role by familiarizing themselves with the indicators of suspicious activity. The Florida Department of Law Enforcement (FDLE) developed indicators for faith-based organizations to use throughout their facilities here.

The Florida "If You See Something, Say Something®" (Florida See Say) campaign educates the public on suspicious activity indicators and emphasizes the importance of reporting suspicious activity to law enforcement. Individuals can report suspicious activity to law enforcement by calling local law enforcement directly, by calling the toll-free statewide phone number at 855-FLA-SAFE, by submitting their tip online via the FDLE Toolkit, or by reporting a tip via the free Florida See Say app which is available in both the Google Play and Apple App stores.
