Executive Actions and Protected Places

Upon assuming office, U.S. President Donald Trump issued a series of Executive Orders to undo previous policies in this regard and to begin to set the agenda for his term, and in the process fulfill several campaign promises. One of those promises was to secure the U.S. border and begin to deport any immigrants that are in the country illegally. This includes being able to make arrests at schools, healthcare facilities, and houses of worship.

In response, several organizations spoke out against this action to include the <u>Episcopal Church</u> and <u>Catholic Church</u>, however these did not address specific actions to take should an incident occur at their respective location. This continues to be an evolving issue. Since this report was written, additional updates were reported by the media and other organizations.

During the month of January 2025, members of FB-ISAO contributed to reports and to raising awareness about similar incidents.

► The report (see above) regarding lifting the status of houses of worship as "protected places" was largely informed by our members.

- Members began to post about the topic and to have virtual conversations about the potential implications.
- FB-ISAO drafted a report on the topic and asked for a member review.
- The collaborative report was published on 29 January.

► Three different members posted information about suspicious activity in three different locations across the country.

- The Co-Chair of the FB-ISAO Operational Resilience Working Group noted the trend and alerted the FB-ISAO team.
- FB-ISAO shared the information (with or without attribution) with Law Enforcement.
